

RELEASE and WAIVER of LIABILITY AGREEMENT

This Release and Waiver of Liability Agreement (this "Agreement") is dated as of the [redacted] day of [redacted], 20[redacted] is made by and between the undersigned (the "Indemnitor") and South Hills Dek Hockey, LLC, and its members, officers, owners, agents, representatives, successors and/or assigns (collectively the "Released Party").

Indemnitor desires to participate in dek hockey and related activities at Released Party's facility located at 1551 Worthington Avenue, Jefferson Hills, PA 15025 (the "Facility"), and as a condition to Released Party permitting Indemnitor to participate in dek hockey and related activities at the Facility, Released Party requires and Indemnitor desires to indemnify, release, and waive any and all liability as to the Released Party as provided herein.

Release and Waiver. Indemnitor hereby generally, unconditionally and irrevocably releases and forever discharges Released Party from all actions, causes of action, suits, debts, dues, sums of money, accounts, reckonings, bonds, bills, specialties, covenants, contracts, controversies, agreements, promises, variances, trespasses, damages, judgments, extents, executions, claims, counterclaims, and demands whatsoever, in law or in equity, whether direct or indirect, known or unknown, anticipated or unanticipated, which the other has, may have, or may hereafter have, in each arising from any accident, injury, theft or damage to any person or property resulting from or in connection with Indemnitor taking part in dek hockey and any and all other activities at the Facility. Furthermore, Indemnitor hereby waives and releases the Released Party from any and all claims, demands, losses, suits and actions of any kind, whether at law, in equity, through litigation or arbitration, in connection with any injury or death to person or damage or loss of property in connection with Indemnitor taking part in dek hockey and any and all other activities at the Facility. Furthermore, Indemnitor having acknowledged awareness of the risks to health and damage to property associated with South Hills Dek Hockey Events, hereby expressly acknowledges and warrants to the Released Party that Indemnitor will take all precautions necessary to protect Indemnitor against such risks, and that such risks shall be the sole responsibility of the Indemnitor. Indemnitor further acknowledges that, but for the execution of this Agreement, and the acknowledgement by Indemnitor of the

provisions hereof, that the Released Party would not allow Indemnitor to participate in dek hockey and any and all other activities at the Facility. The parties hereto hereby agree that the release and waiver contained herein shall continue for each and every visit to the Facility.

This Agreement and the rights and obligations of the parties hereunder shall be governed by, construed and enforced in accordance with the laws of the Commonwealth of Pennsylvania.

I hereby acknowledged that I have read and fully understand this Agreement. I further understand and agree that this Agreement constitutes a waiver of certain legal rights which I may have. My signature (below) has in no way been coerced by the Released Party or by any other person and was provided voluntarily and upon my own free will.
